Form ALF: INSTRUCTIONS

- 1. Article 180 of the CBB Law sets out the CBB's powers to charge fees. Based on these provisions, the CBB charges an annual license fee ('ALF') to all its <u>licensees</u>. Details on the amount of the annual fee for <u>CIUs</u> are included in Module ARR (Authorisation/Registration Requirements) for <u>Bahrain domiciled CIUs</u> and in Module <u>PIU</u> (<u>Private Investment Undertakings</u>). The annual authorisation or registration fee is BD2,000 per <u>CIU</u> or <u>PIU</u>. In the case of umbrella funds, each sub-fund is also charged BD2,000 a year.
- 2. The annual fee is payable at the beginning of the year but not later than April of each year. The payment of the annual fee must be made by using Form ALF (Annual License Fee) and submitted, no later that 30th April each year, together with the payment due. Payment must be made directly to the CBB's bank account as outlined in Paragraph 3 below.
- 3. The <u>operator</u> / <u>trustee</u> (as applicable) must make a direct deposit or wire transfer the payment of the annual fee of the <u>CIU</u> or <u>PIU</u> and inform the CBB of the payment made.
