# CBB Rulebook, Volume 6 (Capital Markets): July 2007 Quarterly Update

This letter summarises the changes being made to Volume 6 (Capital Markets) of the CBB Rulebook, limited essentially at this stage to rules on collective investment undertakings. These changes will shortly be posted on the CBB website, at which point they will have immediate effect. <sup>1</sup>

Recipients impacted by the CBB's collective investment undertaking rules, because of the nature of their business, are required to note these changes and comply with them where appropriate.

#### Background

As you may recall, new Collective Investment Undertaking rules and associated documents, collectively representing the first release of material forming part of Volume 6 (Capital Markets) of the CBB Rulebook, were issued recently.

As with other CBB Rulebook Volumes, any subsequent changes to Volume 6 – if required – are made only on a regular quarterly cycle, to facilitate planning by users of the material (the dates being January, April, July and October).

Any changes (or the fact that no changes are being made for that particular quarter) are communicated to Rulebook users by e-mail, as well as posted on the CBB website.

It is the CBB's intention to minimise the volume of changes as much as possible. However, a few changes are being made this quarter, in response to requests for clarification / comments from the market regarding Module CIU. These changes are described below.

### July 2007 Changes

The following changes have been made in this quarterly update:

#### (1) Module CIU

- (i) Sub-paragraph CIU-5.1.2(b) has been amended, to clarify that the prohibition on administrators and custodians being participants in a CIU would not be expected to apply in the case of overseas domiciled CIUs, where their home regulation allows such participation;
- (ii) The definition of expert and accredited investors who are individuals has been slightly amended, to focus on financial assets available for investment (the same as for companies etc), instead of 'minimum net worth' (difficult to establish). This impacts Rules CIU-B.5.6 and CIU-B.5.10, as well as related Paragraphs CIU-2.1.4, CIU-3.1.4, and CIU-4.2.5.
- (iii) Rule CIU-7.1.3 has been expanded to clarify that, for funds approved by CBB prior to 1 June 2007, they must submit their first quarterly statistical return for the quarter period ending 30 June 2007;
- (iii) Finally, errors in Rules CIU-4.2.7 and CIU-4.2.10 were corrected.

#### (2) Glossary

The definition of 'administrator(s)' was slightly amended and expanded, to clarify the range of activities they may undertake.

The current contents of the Part B folder may be verified by checking the table of contents for Part B, which also lists the applicable date for each Part B item (under the 'Date Last Changed' column).

Late this year, once further Volume 6 content has been released, professionally printed versions of Volume 6, including folders and dividers, will be produced and made available to users, as has been done for other Rulebook Volumes.
