Change to the Due date and Collection Process for the Payment of the Annual License Fee

As advised last December, for 2014 and the following years, the due date for the payment of the Central Bank of Bahrain ('CBB') annual license fee has now been changed to 1st December of the previous year for which the annual fee is due. As a result the 2014 annual license fee must be paid to the CBB by 1st December 2013.

In addition, all licensees will be required to pay the annual fees by direct debit and must complete the Direct Debit Authorisation Form attached and submit this form to the CBB by 15th September 2013 at the latest.
