There shall be added to the Fee categories for licences and services provided by the Central Bank of Bahrain indicated in Table attached to Resolution No.(1) of 2007 with respect to Determining Fee Categories due for Licenses and Services provided by the Central Bank of Bahrain, new fees as determined in the manner indicated in the Table attached to this Resolution.

#### Article 2

The Governor of the Central Bank of Bahrain shall implement this Resolution which shall be published in the Official Gazette and shall come into effect from the day following the date of its publication.
