- 6. The Form must be either typed or handwritten.
- 7. The replies to each question must be specific and not in 'Yes' or 'No form; unless this is given as an option to the question itself.
- 9. All the questions must be answered and in the case of a question not being relevant 'N/A' can be written.
- 10. The information on the transferee is to be obtained by the transferor and must be correct in all respects.
- 11. Applicants should note that the CBB reserves the right to request any other information or documentation before considering whether to approve the proposed transfer.
