Form 2: INSTRUCTIONS

INSTRUCTIONS

PLEASE NOTE:

1. All persons wishing to be authorised to be a controller of a Islamic bank licensee or seeking to increase their level of control must receive prior CBB authorisation pursuant to Resolution No. (16) of 2021 with respect to promulgating the Regulation Pertaining to Control in Banks ‘Control Regulation’, and Articles 52 to 56 of CBB Law.
2. A controller in a Bahraini Islamic bank is defined as:
 - a) A person who, either individually or together with an associate, owns 10% or more of the share capital of a licensed bank or of a Holding Company of a licensed bank (as defined in the Control Regulation),
 - b) A person who, either individually or together with an associate, is able to exercise voting right determined for whoever owns 10% or more of the share capital of a licensed bank or of a Holding Company of a licensed bank (as defined in the Control Regulation),
 - c) A person who, either individually or together with an associate, is able to exercise significant influence over the management of a licensed bank or a Holding Company of a licensed bank (as defined in the Control Regulation).
3. For overseas Islamic bank applicants (foreign branch), the controller is the parent bank.
4. This application form should be completed by referring to the Control Regulation and Articles 52 to 56 of CBB Law. Licensed banks and applicants must accordingly satisfy themselves that they meet the above requirements before submitting an application.
5. This form contains the principal elements that are required, but should applicants consider that there is additional evidence of relevance to the application, this should be submitted with this form. It should not be assumed that information is known to the CBB merely because it is in the public domain or has previously been disclosed to the CBB or another regulatory body. If there is any doubt about the relevance of information, it should be disclosed.
6. Please complete all sections as fully as possible, attaching supporting documentation and continuation sheets where appropriate. The application must be written in ink in BLOCK CAPITALS or typed.
7. This application must be accompanied by the following documents and information:
 - (a) A complete resume of the applicant and his/its named associates.
 - (b) A list of companies in which the applicant and his/ its named associates own 10% or more of their share capital along with copies of the latest audited financial statements of such companies and the proposed applicant.
 - (c) Credit reference reports of the applicant and all of his/ its named associates by the relevant credit reference bureaus.
 - (d) Where the applicant and any of his/ its named associates are natural persons, a copy of their passports and personal identification cards.
 - (e) Contact details of three persons from institutions or regulatory authorities that the CBB can contact to inquire about the applicant and his/ its named associates.
 - (f) Where the application relates to a change of the current controller pursuant to Article (4) of the Control Regulation, the documents specified in (a), (b) and (c) above must be submitted for each shareholder owning 10% or more of the holding company of the licensed bank.
 - (g) If the applicant is a regulated entity, an undertaking letter from it and its named associates regarding their commitment to support the licensed bank to be controlled in an amount equivalent to their proposed shareholding in the capital of the licensed bank.



- (h) A written description of the current and past relationship with the licensed bank.
- (i) If the proposed controller is a legal entity, a chart showing the ultimate owners of the proposed controller and the proposed controller's ownership interest percentages in its subsidiaries and associated companies.
8. Failure to provide all the required information may result in significant delays in processing. The CBB does not accept responsibility for any loss caused to the applicant by any delay.
9. All documentation provided to the CBB must be in either the Arabic or English languages. Any documentation in a language other than English or Arabic must be accompanied by a certified English or Arabic translation thereof.
10. If any question is not applicable given your particular circumstances, please clearly indicate by marking 'N/A', with an explanation as to why it does not apply. Please provide a full explanation for any question that cannot be answered at this stage. Please note that failure to provide the required information may prejudice an application and will cause delay.

Form 2: DECLARATION

We/I further undertake that, in the event that the authorisation of controller being sought is granted, we/I will notify the CBB and the bank of any material changes to or affecting the completeness or accuracy of, the information provided in this form as soon as possible, but in any event no later than 15 days from the day that the changes come to our/my attention.

We/I confirm that we/I did not make or intend to make any concerted efforts or arrangement with a third counterparty, whether in writing or otherwise, to exercise control over the bank, and if such efforts or arrangement is made or to be made, we/I undertake to notify the CBB immediately.

We/I confirm that our funds are from legitimate sources, and that following the acquisition of shares, we/I will submit to the CBB, within two months from the date of the acquisition, a report prepared by an independent external auditor (along with supporting documentation) detailing the source and audit trail of the funds used to acquire the shares.

We/I confirm that to the best of our/my knowledge, we/I have provided a complete list of:

- All named associates as defined in the Control Regulation;
- Related parties (including family members);
- Business partners; and
- All companies in which we/ I own 10% or more and specifying whether such companies have any shareholding interest or voting power in, or any type of influence over, the bank. The list should indicate in detail the shareholding interest or voting power in, or the type of influence over, the bank.

We/I also confirm that we/I have read Articles 52 to 56 of CBB Law and the Control Regulation and understood them clearly and hereby undertake that we/I will comply with, and abide by, all such requirements and other applicable Laws and regulations in the Kingdom of Bahrain, and we/I undertake to inform the CBB and the bank in writing in case we/I have committed any violation of such requirements and applicable Laws and regulations.
