<u>CBB Rulebook: Volume 5 (Specialised Licensees: Financing Companies) – April 2014 Update</u>

The April 2014 quarterly update to Volume 5 Financing Companies has now been incorporated in the website version of the Rulebook.¹

The contents page for each Module shows the date each section was last changed and provides a good reference tool to keep track of the latest updates along with the Module History.


