<u>CBB Rulebook: Volume 5 (Specialised Licensees: Money Changers) – October 2012 Update</u>

The October 2012 quarterly update to Volume 5 has now been incorporated in the website version of the Rulebook.¹

This letter highlights changes introduced this quarter. Licensees are required to note any policy changes. In addition, recipients who wish to update their hard copy folders should access the Central Bank of Bahrain ('CBB') website and print off the relevant pages for insertion into their folder.

All changes are highlighted in colour in the PDF versions of the Modules included on the CBB's website. All changes to the text of the previous version of Volume 5, however minor, are highlighted. The searchable version of the Rulebook, in addition, allows users to list changes and compare different versions of the Rulebook.


Contents Pages and Module History

Module AU

Module AU has been amended to specifically address the wholesale export and import of various currency bank notes in physical form, for the purpose of distribution /collection to/from the local market or for transmission to a foreign jurisdiction. Only Licensees permitted by virtue of a special condition set out in their license, specifying that they may deal in the import/ export of bank notes, are permitted to engage in this activity.

Module EN

Module EN includes a new Section EN-5.3A on financial penalties for date sensitive requirements. The financial penalties in relation to date sensitive compliance issues have been standardised to a daily amount for each requirement that is late. These penalties will be enforced for any past due requirements after 1st January 2013, without prior notice being issued to the licensee. All licensees should therefore be fully familiar with all date sensitive requirements included in Volume 5 and should ensure that they meet these requirements at all times. The compliance officer is required to ensure that all senior managers are fully aware of such enforcement actions.
