CBB Rulebook: Volume 5 (Specialised Licensees: Representative Office) – January 2013 Update

The January 2013 quarterly update to Volume 5 has now been incorporated in the website version of the Rulebook.¹

The contents page for each Module shows the date each section was last changed and provides a good reference tool to keep track of the latest updates along with the Module History.


