<u>CBB Rulebook: Volume 6 (Capital Markets):</u> <u>July 2011 Quarterly Update</u>

This letter summarises the changes being made to Volume 6 (Capital Markets) of the CBB Rulebook. These changes will shortly be posted on the CBB website, at which point they will have immediate effect. ¹

This letter highlights changes introduced this quarter. Licensees are required to note any policy changes. In addition, recipients who wish to update their hard copy folders should access the Central Bank of Bahrain ('CBB') website and print off the relevant pages for insertion into their folder.

All changes are highlighted in colour in the PDF versions of the Modules included on the CBB's website. All changes to the text of the previous version of Volume 6, however minor, are highlighted. The searchable version of the Rulebook, in addition, allows users to list changes and compare different versions of the Rulebook.


Contents Pages and Module History

Release of High-Level Controls (Corporate Governance Module)

Following the consultation which concluded on 1st June 2011, the CBB is now issuing its new Module HC (High-Level Controls (Corporate Governance)) for Volume 6 (Capital Markets). The new rules take effect on 1st September 2011. All listed companies and capital market service providers (CMSP) to which the Module HC applies should be in full compliance by the financial year end 2011.

The Module sets out the CBB's regulatory framework for corporate governance in Bahrain with respect to CMSPs. It aims to introduce a consistent, effective and harmonised approach in the regulation and supervision of corporate governance in line with the principles laid out in the Corporate Governance Code of the Kingdom of Bahrain.

CMSPs and listed companies should take measures to ensure compliance with the new requirements from the effective date and any CMSP that may be non-compliant with the new rules should advise the CBB of their status accordingly.

The new rules benefitted from industry comments and feedback received during the consultation process, and the CBB looks forward to working with you in implementing these rules.
